Dead fish show up on **Delaware Bay beaches**

MIDDLE TOWNSHIP – A significant amount of dead bait fish washed up on Delaware Bay beaches in Middle and Lower Township

County health officials do not know the source of the dead fish, but the origin could be as simple as a broken fishing net that released hundreds or thousands of dead fish.

'We don't know too much," said Linda Wilde, Director of the Division of Environmental

Health with the Cape May County Health Department. "The DEP has been contacted and they are trying to get water samples.

Wilde said they had received phone calls and every indication is they are small mullet, which would be caught for bait.

"Usually this happens on the ocean side, when bait nets break," she said. "It could be as simple as that. Most likely they are from a baitfish boat, but we don't know for sure. The DEP has to get some to their lab for testing."

Wilde said she notified Public Works in Middle and Lower Township that they might want to try cleaning up the fish before they started to smell.

However, by Wednesday afternoon the smell of rotting fish was strong in areas of the

Green Acres money for Vance's

CAPE MAY – The City of Cape May has applied to the New Jersey Department of Environmental Protection for a Green Acres grant to fund 50 percent of the cost of a project aimed at acquiring the former Vance's Tavern property for open space.

The Green Acres Program was created in 1961 to help municipalities fund recreation and conservation projects. According to City Manager Bruce MacLeod, the program has two funding methods one for 25 percent and the other for 50 percent. The city, he said, is

eligible for 50 percent funding because it has its own open space

"The application was submitted to the NJDEP Green Acres Program," MacLeod said. "The total project budget is approximately \$3.29 million. The grant that the city has applied for is equal to 50 percent, or \$1,645,000. It requires an equal match."

Cape May's open space fund is maintained by an appropriation that is basically one cent on the tax rate. He said there are two types of funding for municipal open space programs. One is specifically a

"Cape May County's open space

fund is an actual tax," MacLeod said. "The other, which is the city's program, is to create an appropriation in the current fund basis, which is on apportion with one cent on the tax rate."

MacLeod said the open space money is set aside in a special fund until such time as it is needed, and then council authorizes an appropriation. He said it's the city's intention to use money in its open space fund toward its 50 percent of total project. He said the fund now has about \$1.6 million in it, but the city has an obligation to use some of those funds toward the acquisi-
