"Using the example of somebody who just chops down a tree within the definition of the code without a permit, they can be issued a summons potentially, but it becomes a code enforcement issue, they can be cited, they can issue a stop work order," Gillin-Schwartz said.

## Point addressing high level of Lake Lily

Commission must include

CAPE MAY POINT A lot of rain has fallen this spring, resulting in a heightened groundwater level and surface level of Lake Lily, and Borough Commission is taking

steps to address the issue.
"We are working working through some issues with our ability to pump down the level of the lake," Commissioner Catherine Busch said during a meeting April 23. "We're still in the diagnosis phase."

The commission intro-

duced an ordinance regulating tree removal and replacement to bring the borough into compliance with new requirements from the Department of Environmental Protection. Second reading and a public hearing on the ordinance are scheduled for

the next meeting at 6 p.m.

May 9.
"In order to have our stormwater permit, we're required to have such an ordinance," Busch said. "There will be more information on that once it's been introduced."

Borough Commission passed a resolution granting A.P. Construction a temporary water connection during the Higbee Beach Restoration Project.

Busch said the contractor's construction trailer has facilities but no water hookup.

"In order for them to be able to get water from us just during the construction project, we had to have special agreement drawn up," Busch said.

The agreement is only for the life of the project and A.P. Construction will pay the costs of water and connection.

"It will be disconnected at the end of the project,' Busch said, noting the only permanent water line services Sunset Beach Cape May Point State Park, which purchase from the borough.

"We made sure the borough is covered and making it easier for those people down there to have use of water other than trucking it in each day, she said.

Mayor Bob Moffatt reminded residents they can purchase pre-season beach tags beginning May 1 at Borough Hall.

"I also wanted to take a minute to thank Ed Grant and John Amenhauser for working with the City of Cape May and the municipal court on the municipal court services contract, which we should be receiving shortly," Moffatt
