## **DeSatnicks** grill mayor on lack of slope study

CAPE MAY — Dennis DeSatnick, a member of the city's Beach Safety Committee whose son suffered a spinal injury in Cape May's surf submitted an Open Public Records Act request with the city for all emails, documents and paperwork related to beach safety.

The city has been working with the U.S. Army Corps of Engineers, state Department of Environmental Protection (DEP), Stockton University's Coastal Research Center, Beebe Health System in Lewes, Del., and Cape Regional Medical Center to address a heightened number of beach injuries in the city's surf zone.

During an Oct. 18 City Council meeting, his wife, Anita DeSatnick, who is also a Beach Safety Committee member, said the information was received one week ago.

"When Denny and I were reading these over, there were a few that stood out to me, that really knocked me off my feet, to be honest with you," she

She read aloud a May 5, 2016, email from Mayor Edward Mahaney to Stockton University Coastal Research Center Executive Director Stewart Farrell in which the mayor thanked Farrell for forwarding a copy of the Delaware Surf Zone Injury paper.

"At my request, the city has just formed a beach safety committee to research and mitigate the surf zone injury issue on a multifaceted basis,'

Mahaney said in the email. "At your request there was a beach committee formed?" asked Anita De-

Mahaney replied "yes." She said the committee was the result of her son, Chad DeSatnick, her husband and herself asking council for years to address the issue.

In a July 29 email from Mahaney to Farrell, the mayor asked Farrell to participate in a "panel presentation of beach conditions on the Cape May oceanfront." Mahaney stated the Army Corps and DEP were on board to hold a town meeting on the "intertwined topics of sea level rise, climate change beach replenishment and surf-tidal

"Hopefully, such a presentation will quell this ongoing misinformed notion about a correlation between head/ neck injuries of bathers and the beach

# Furlin says Lear paid for illegal

CAPE MAY — During council comments at an Oct. 18 City Council meeting, Councilman Roger Furlin launched into a nearly 20-minute monologue against retired Cape May Police Department Lt. Chuck Lear, a candidate in the mayoral election

Reading from a number of pages, Furlin accused Lear of illegally receiving overtime pay. Lear retired and settled with the city effective Jan.

Furlin said he was answering comments made by former police chief Robert Boyd during public comment at a council meeting last month con-cerning a resolution accepting Lear's settlement agreement for retirement. Boyd criticized the city for not acknowledging Lear's 37 years of service to the police department. Furlin said the resolution was not a celebration but a reprimand for accumulating what he termed "illegal overtime compensation." He said salaried employees were prohibited from receiving overtime or comp time pay.

Furlin addressed Boyd's earlier comment of a conspiracy to get rid of Lear, a lieutenant, so a sergeant could be promoted to chief of police. He said a complaint was filed against Lear by the police union and another from a citizen.

Councilman Shaine Meier said City Manager Bruce MacLeod approved Lear's overtime hours. Meier asked if Furlin was slamming Lear for political

"Why are you doing this?" asked Meier. "You weren't even here when it happened."

Furlin said City Council approved an independent investigator to look at Lear's overtime hours. He said Lear amassed 1,424 hours of comp time and cashed in unused vacation time because he was using comp time.

Furlin claimed Lear's contract was salaried and did not allow overtime pay or comp time regardless of number of hours worked. He claimed Lear reneged on his first proposed settlement agreement, which was identical except for a retirement date of Jan. 1 rather than July 1. Furlin said Lear told him he did not take comp time, he took flex time. Furlin said his life mantra was "honor your agreements."

### Cape May approves lawsuit settlement with gay former cop

CAPE MAY — City Council approved a settlement with former Cape May police officer Steven Pascal on Oct. 18.

The original lawsuit named the city and Capt. Robert Sheehan as defendants "based on alleged acts of harassment, discrimination and retaliation that occurred within the police department and without knowledge of the city administration."

The settlement totals \$369,000, which according to a statement

According to the city's statement, over the years Pascal, an openly gay officer, had complained to former police chief Diane Sorantino of the harassment he received by members of the community as well as various acts of harassment, discrimination and the city. "There were two indi-

Monzo handled a departmental hearing and a decision was made by retired Superior Court Judge Richard J. Williams to uphold the recommendation of the police department to terminate Pascal as a police officer. The final decision was made in 2013 by City Manager Bruce MacLeod as the appropriate authority and not by the governing body, according to

"It was not until after the termination hearing that many of the alleged complaints about harassment, discrimination and retaliation surfaced through the litigation, including the various alleged homophobic slurs and threats made by members of the public that were not, according to Mr. Pascal, adequately addressed by the police department," stated the city. "As a result, the city, along with Captain Sheehan, was sued claiming wrongful termination
